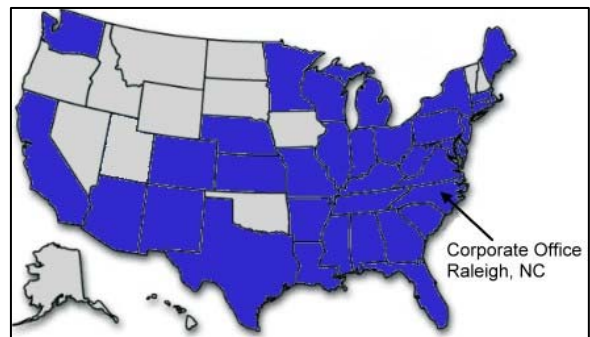

- 4.1 **Senior Security Consultant:** A Senior Consultant is a security professional with over ten years' experience as a security professional.
